## National Spiritual Assembly Launches Volunteer Programme

25th February, 2003

DEARLY LOVED FRIENDS

The National Spiritual Assembly is very excited to announce the establishment of a Volunteer Programme for friends in the Greater London area and South East England who would like to offer their services as volunteers at the National Hazíratu'l-Quds in London and at the National Sub-Office in Tonbridge, Kent.

This programme is being inaugurated following earnest consultation on guidance recently received from the Universal House of Justice on the essential role of volunteers in the running of the affairs of the Cause, as well as the National Assembly's desire to enhance the spirit of service among the friends and their involvement with the important work of the national Bahá'í administration.

As you know, 27 Rutland Gate is an important historic site, unique in the Bahá'í world. The funeral cortege of the beloved Guardian began its journey from this place. The Universal House of Justice held some of its critical first meetings in the council chamber of the National Spiritual Assembly while the Hands of the Cause of God formulated many of the features of the Nine Year Plan (1964–1973) in that same building. Since its refurbishment at the request of the Universal House of Justice, the building has hosted numerous important receptions and events, not least of which was the visit of HRH the Duke of York last July, as well being a first port of call for Bahá'ís from all over the world visiting London.

The National Spiritual Assembly wishes to set up an effective programme of service at 27 Rutland Gate, whereby friends are invited to volunteer as guides, providers of hospitality and welcome, and for bookshop sales. There will be two shifts per weekday, from 09.30–13.00 hrs and from 13.00–17.00 hrs. This role may also include some administrative support including answering telephones, filing, indexing, research and photocopying. We would also particularly like to hear from Persian-speaking friends who would be able to handle calls from other Persian-speakers.

The National Spiritual Assembly believes these roles would ideally suit young people who have some opportunity in their study schedule to offer, say, one morning or afternoon a week, or recently retired friends and senior citizens who would like to offer some of their free time to the work of the Cause.

We would also be interested to hear from any youth who can support themselves financially and are considering offering a year, or shorter period, of service. At the National Sub-Office in Tonbridge, assistance is required on an ongoing basis in general office work, assistance with mailouts and helping with the work of the Finance Department.

The National Spiritual Assembly would also like to appoint a Volunteer Coordinator who, possibly working from home, could manage the rota of volunteers and ensure the programme is adequately and effectively staffed.

The National Spiritual Assembly is confident that the new spirit of service prevailing in the

community will encourage you to arise to assist the important work of the National Spiritual Assembly. #### WORLD CONFERENCE ON RELIGION AND PEACE

The National Spiritual Assembly has been informed by the Bahá'í International Community's Office of Public Information that the Bahá'í International Community (BIC) has withdrawn its official affiliation from the World Conference on Religion and Peace (WCRP). A letter from BIC explains:

While we greatly value the Faith's association with organisations with purposes akin to Bahá'í aims, we necessarily expect that such organisations adhere to a process of decision-making that consults the members of the organisation before assuming positions, making statements and taking action on their behalf. Regrettably, WCRP has not observed this principle and has published statements without due regard for a consultative process...

While it is the manner in which the organisation is being run that we do not appreciate, WCRP is an organisation with laudable aims and worthwhile programmes. Your Assembly should consider on a case-by-case basis in which activities it wishes to be involved, strictly avoiding any involvement in political positions on controversies of the day. As with involvement in any such organisation, care and wisdom are required for effective participation.

In light of this the National Spiritual Assembly has decided to withdraw from membership of WCRP UK. It should be emphasised that this is no reflection on the conduct of the UK Chapter nor is it a criticism of the aims of WCRP.
