DENVER MAN'S HOME IS BOMBED THIRD TIME
NATIONAL ASSOCIATION BRANCH ACTIVE

Effort To Oust E. E. Carrington From His Home In A
'White Neighborhood' Shots Are Fired From Ambush

New York, N. Y. January 28.—The National Association for the Advancement of Colored People is informed by its Denver, Colorado Branch, that for the third time within two months the home of E. E. Carrington, a colored man, had been attacked. The first attack occurred at 2 o'clock on the morning of December 10, a bomb being placed under the porch of the Carrington house and blowing a hole in the porch as well as arousing the entire neighborhood. The second attack occurred on January 2, when six shots were fired at the house from ambush while Mrs. Carrington was standing talking to a neighbor. Three of the bullets penetrated the window, just back of Mrs. Carrington. A little later that evening shots were fired at the rear of the house shattering an electric bulb on the sleeping porch.

The latest attack, on January 15, was in the form of a bomb hurled on Mr. Carrington's front porch at 6 o'clock in the evening. Mr. Carrington rushed out of the front door, seized the bomb and tossed it to the street. It exploded, the concussion shattering a window in a next door neighbor's house. Mr. Carrington has received repeated threatening letters warning him to move (from what is a white neighborhood).

The Denver N. A. A. C. P. under the presidency of Geo. W. Gross, has appealed to the authorities for protection and is in constant communication with the National Office of the N. A. A. C. P. which is following the situation closely. The National Office of the N. A. A. C. P. has offered full assistance to the Denver Branch in dealing with the bomb terrorism.

"ARROW TIPS" By Kits Reid

The Advocate does not necessarily share in Kits Reid's views, but whether we do or not, her opinions are sane, and logical and well worth reading. It is your privilege as well as ours to disagree with Kits and she invites your opinion upon subjects she discusses from time to time in her column.

How long, Oh, Lord, how long must this country endure Coolidge and Kellogg? Is it possible that we are going to stand by and stupidly allow them to force the American nation into another disgraceful war with Mexico such as we had in 1846—a most "shameful and inglorious blot on the history of this country? Is it generally known that the tool we call the president has ordered 6 more war ships and a small army of 4000 men to Nicaragua under the thin excuse the American property and lives are being menaced by the "revolutionists" in that country. I have bracketed the word "revolutionists" because that is what our commander-in-chief of our army and navy calls them. But is that the real reason? I have read everything I can get my hands on and I find not one iota of evidence that there has ever been any threat even in that direction. But I do find plenty of evidence that Coolidge and Kellogg, between them, are obeying the dictates of Wall Street capitalists and are sending American boys down there to die for the sake of the American oil and mineral land owners in Mexico, using the Nicaraguan incident as an excuse.

There has been a civil war (is one of a kind now) between two forces in Nicaragua. The majority element led by President Sacasa has been recognized by Mexico as the legal government of that country. Diaz, the claimant of the minority faction is recognized by the United States. Coolidge—Wall Street rather—charges that the Mexican government is furnishing arms and munitions to Sacasa and feels that this justifies the United States in supplying

"THE AMERICAN RACE PROBLEM"

"We brought the Negro over from Africa in Colonial times, without his consent and against his interests. He has since won through to freedom and a certain definite place in our affairs. How the white race can be fair to him and at the same time conserve its own interests is the subject of this searching and unprejudiced study, which deserves the attention of both races."

The above salient statement adorns the cover on E. B. Reuter's brand new book, "THE AMERICAN RACE PROBLEM".

Professor Reuter, who holds the chair of social Science at the University of Iowa, approaches the question in an attitude so obviously impartial as to inspire the respect and confidence of students. In seventeen chapters he reviews every phase of the Negro problem, and from the standpoint of the Negro no less than the Anglo-Saxon.

In his introductory chapter the author reviews the whole situation, stating that the Negro people today offer the best opportunity in the modern world to study a race in evolution. Next he studies Race as a sociological concept, racial differences and tendencies, the contact of races and cultures, the primitive Negro when he first reached America, the disappearance of his original language and customs, and the effect of slavery upon his status. The Negro in Slavery in fact occupies several chapters and is viewed biological-

WILLIAM PICKENS IN RUSSIA; WRITES ON LYNCHING FOR MOSCOW PAPERS

Says "Fire In The Flint", "Bursting Bonds", "Vengeance Of The Gods" To Be Published In Russian Language

New York, N. Y. January 29.—Letters have been received by the National Association for the Advancement of Colored People, 69 Fifth Avenue, from William Pickens, Field Secretary of the N. A. A. C. P., who has visited Russia on his European lecture tour.

Mr. Pickens states that he addressed an audience in Moscow including 22 Chinese generals, a number of Russian leaders and representatives of ten to twelve nations and races. The entire group, writes Mr. Pickens was photographed at least 50 times, motion pictures being made of the speakers in action.

Among the Russian leaders Mr. Pickens has conferred with are Kalinin, sisters of Trotsky and Lenin, and prominent editors. He reports that "The Fire In The Flint" by Walter White, and "Bursting Bonds" and "The Vengeance of the Gods" by Mr. Pickens himself are to be translated into Russian, and perhaps put on the stage as well as made into motion pictures.

Mr. Pickens has written a comprehensive article on lynching during the past forty years, detailing the campaign conducted for seventeen years against this evil in America by the N. A. A. C. P. This article is to be published in newspapers in Moscow, Berlin and Paris, writes Mr. Pickens, who has also written for Russian magazines on American race problems.
